



Participant Release, Waiver and Covenant Not to Sue for Minors

TOURNAMENT WAIVER

I confirm that I am the Parent/Legal Guardian of the Minor/Ward ("Participant") listed on the attached Participant Release, Waiver and Covenant Not to Sue for Minors signature page. I also understand that as a condition for the Minor/Ward to participate as a Player or Caddie in Georgia State Golf Association ("GSGA") competitions through December 31, 2022, I, as Parent/Legal Guardian of the Minor/Ward, certify and attest to the following:

- 1) As Parent/Legal Guardian of the Minor/Ward, I grant the GSGA the right to videotape, film, and photograph the Participant, and the right, in perpetuity, to use their name, likeness, and biographical information, in all forms of media (including the Internet), in conjunction with advertising and promotion of the GSGA and with regard to any tournaments, seminars, or events hosted by the GSGA.
- 2) I confirm my electronic registration, together with any payment, constitutes my agreement with the GSGA Policies, Terms and Conditions, and that both I and the Participant and any spectators invited to any GSGA event by me, will abide by the GSGA's Rules and Policies (including the Dress Code, Code of Conduct and Spectator Policy). I further understand and acknowledge that neither the Host Facility nor the GSGA is responsible for any lost or stolen items, and that I and the Minor/Ward are responsible for the Minor/Ward's property at all GSGA events.

COVID-19 RELEASE, WAIVER AND COVENANT NOT TO SUE

- 3) I understand that there are certain risks inherent in the game of golf. I also understand that my Minor/Ward's participation in any competition and use of event facilities and equipment may be dangerous and could involve the risk of serious injury, even death.
- 4) In light of the COVID-19 pandemic, I acknowledge for myself and my Minor/Ward, that any level of involvement or participation in these kinds of events may expose me/ my Minor/Ward to various viruses or infections that could be dangerous or even deadly.
- 5) I understand that my Minor/Ward may be required to provide certifications and participate in a health screening verbal questionnaire on site at each competition, before teeing off, and if my Minor/Ward refrains from providing certification or participating in the questionnaire, or if the answer is "YES" to any questions, my Minor/Ward may not be allowed to participate in the competition. The questions asked during the on-site health screening and verbal questionnaire will include, but may not be limited to, those related to recent exposure to individuals with COVID-19, as well as testing positive for and/or experiencing common symptoms of COVID-19.
- 6) For myself and on behalf of my Minor/Ward, I acknowledge that from the time we arrive at the host venue, with the exception of sharing a golf cart with a Participant and/or a GSGA official, including choosing to use a GSGA-provided shuttle, we will adhere to social distancing and will make every effort to maintain at least six (6) feet of space between myself and all other persons during all competitions conducted by the Georgia State Golf Association.

- 7) For myself and on behalf of my Minor/Ward, I acknowledge that we will follow all signage, instructions, policies and procedures communicated by the GSGA and/or the host club/facility and understand that my Minor/Ward may be subject to penalty, including disqualification, should we deliberately or knowingly violate any of these instructions, policies or procedures.
- 8) I understand that during emergencies, including but not limited to suspensions of play for dangerous weather or other situations, the Georgia State Golf Association will likely not be able to ensure safe social distancing throughout a suspension.

ASSUMPTION OF THE RISK

- 9) I understand that the Georgia State Golf Association has implemented policies and procedures in an effort to help provide a safe environment for my Minor/Ward and others to participate in GSGA activities, but neither the GSGA, the host facility, nor I can control the conduct of others. For myself and my Minor/Ward, I understand that I am assuming all risks with my Minor/Ward's participation in GSGA activities.

RELEASE, WAIVER AND COVENANT NOT TO SUE

- 10) For myself and my Minor/Ward, I hereby waive and release any and all claims and liabilities, now known or hereafter known, against the GSGA, its officers, board of directors, members, partners, employees, agents, sponsors, contractors, and all of their successors and assigns, (collectively Releasees), on account of (a) injury, disease, infection, death, and property theft or damage, arising out of or attributable to the presence or participation of myself or my Minor/Ward, at a competition, and arising out of the actual, perceived, or alleged negligence of any Releasee, (the "Released Claims"). I covenant not to make or bring any Released Claim against any Releasee, and forever release and discharge all Releasees from liability under such claims. It is my intent that this Release, Waiver and Covenant Not to Sue will bind myself and my personal representatives, spouse (if applicable), assigns, heirs, and next of kin without limitation for myself and my Minor/Ward, and shall be deemed as a RELEASE, WAIVER, DISCHARGE, AND COVENANT NOT TO SUE all Releasees in connection with the Released Claims.
- 11) I further agree for myself and my Minor/Ward that I cannot terminate or rescind this Release, Waiver, and Covenant Not to Sue. It is my desire and intent that the terms, provisions, covenants, and remedies contained in this Release, Waiver and Covenant Not to Sue be enforceable to the fullest extent permitted by applicable law. If any term or provision of this Release, Waiver and Covenant Not to Sue is deemed invalid, illegal, or unenforceable in any jurisdiction, such invalidity, illegality, or unenforceability will not affect any other term or provision of this Release, Waiver and Covenant Not to Sue, nor invalidate or render unenforceable such term or provision in any other jurisdiction. The GSGA may assign this Release, Waiver and Covenant Not to Sue and its rights hereunder, in whole or in part, to any party. This Release, Waiver and Covenant Not to Sue is binding on and inures to the benefit of our respective heirs, executors, administrators, legal representatives, successors, and permitted assigns. All matters arising out of or relating to this Release, Waiver and Covenant Not to Sue shall be governed by and construed in accordance with the laws of the State of Georgia without giving effect to any choice or conflict of law provision or rule (whether of the State of Georgia or any other jurisdiction). Any claim or cause of action arising under this Release, Waiver and Covenant Not to Sue may be brought only in the federal and state courts located in Cobb County, Georgia and I hereby irrevocably consent to the exclusive jurisdiction of such courts.
