

**CONDITIONS OF COMPETITION - The following conditions shall be in effect for this competition:**

- GSGA competitions are "spikeless" events. Therefore, metal and traditionally-designed spikes are prohibited. Penalty for breach of this condition is disqualification.
- Players are responsible for posting their scores to the handicap system upon conclusion of this competition. Scores must be posted as tournament scores. Course slope and rating information is typically posted at the scoreboard during the competition. You may also contact GSGA for this information. Your scores are subject to review by your peers and your club's handicap committee.

<b>EVENT</b>	Atlanta Amateur Match Play Championship
<b>ELIGIBILITY</b>	Entries are open to male amateur golfers. Handicap indexes listed in the current revision at the time entries close will be used in determining eligibility.
<b>FIELD</b>	120 players with the lowest handicap indexes and the defending champion will comprise the field.
<b>FORMAT</b>	<ul style="list-style-type: none"> <li>• Thursday, September 14<sup>th</sup> - 18 holes stroke play for all 120 players <ul style="list-style-type: none"> <li>○ Low 31 and defending champion advance to match play</li> </ul> </li> <li>• Friday, September 15<sup>th</sup> - a.m. Round of 32, p.m. Round of 16</li> <li>• Saturday, September 16<sup>th</sup> - a.m. Quarterfinals, p.m. Semifinals</li> <li>• Sunday, September 17<sup>th</sup> - a.m. Championship Match</li> </ul>
<b>PRACTICE ROUNDS</b>	<p>One practice round per player. Practice rounds will be available on the designated dates and times below, based on club availability. Practice rounds are for players only. Please call <a href="#">Rivermont Golf Club</a> to reserve your practice round starting time after September 1, but no more than 48 hours in advance. Practice round cart and range fee is \$30 plus tax. Cash and credit cards will be accepted for golf shop payments.</p> <ul style="list-style-type: none"> <li>• Monday, Wednesday, Thursday, after 1:00 p.m. based on availability.</li> <li>• Saturday-Sunday after 3:00 p.m. based on availability.</li> </ul>
<b>YARDAGES &amp; TEES</b>	The RED tee markers and yardages will be utilized. Yardages are approximate and may be adjusted due to inclement weather or other factors that may affect the playing conditions during the competition.
<b>GOLF SHOP &amp; DRIVING RANGE:</b>	The golf shop and driving range will open at 6:30 a.m. each day of the championship.
<b>STARTING TIMES</b>	Starting times for tournament play will be assigned by the GSGA and posted at the club the day before the competition starts. You may visit <a href="http://www.gsga.org">www.gsga.org</a> for complete pairing information and starting times beginning September 7. <i>No starting time requests will be honored.</i>
<b>REGISTRATION</b>	No formal registration will be held. Instructions will be given on the starting tee.

<b>CARTS</b>	Practice round cart and range fees are \$30 plus tax. Cash and credit cards will be accepted in the golf shop. Cart fees are required for all aspects of the Championship. Players who choose to walk must still pay for a cart. Practice round and match play cart fees are the responsibility of the player. Thursday, September 14 <sup>th</sup> stroke play cart fee is part of the entry fee. Cart fees for match play will be \$30.00 plus tax per day and will include range balls.
<b>CADDIES</b>	Caddies are permitted. Players may provide their own caddie. Caddies are not available from Rivermont Golf Club.
<b>RULES OF PLAY/PACE OF PLAY/CART POLICY</b>	The GSGA Rules of Play, Pace of Play and Cart Policies shall be in effect. <a href="#">Click here to view the policies.</a>
<b>FOOD SERVICE</b>	Food service will be available from the clubhouse and halfway house every day. CASH ONLY will be accepted for F & B.
<b>PRIZES</b>	Gift certificates will be awarded to the 32 players that advance to match play.
